

NOTIFICATION

No. 100/WB-LA/04/2021:– WHEREAS, the Commission’s Notification No. 308/WB- LA/2021 dated 3rd May, 2021, issued under Section 73 of the Representation of the People Act, 1951, in respect of the Legislative Assembly of West Bengal, the name of Shri Kajal Sinha was listed as the Member elected from 109-Khardaha AC, the result whereof was declared on 2nd May, 2021; and

2. Whereas, the seat of Shri Kajal Sinha, in the Legislative Assembly of the State of West Bengal, elected from 109-Khardaha Assembly Constituency has fallen vacant due to his demise after the poll; and
 3. WHEREAS, a bye-election is to be held for the purpose of filling the said vacancy;
 4. NOW, THEREFORE, in pursuance of sub-section (1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission hereby:-
 - A. Calls upon the said 109-Khardaha Assembly Constituency in the State of West Bengal, to elect, before the 5th November, 2021 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the said Legislative Assembly; and
 - B. Appoints, with respect to the said election: –
 - a) the 8th October, 2021 (Friday), as the last date for making nominations;
 - b) the 11th October, 2021 (Monday), as the date for the scrutiny of nominations;
 - c) the 16th October, 2021 (Saturday), as the last date for withdrawal of candidatures;
 - d) the 30th October, 2021 (Saturday), as the date on which a poll shall, if necessary, be taken;
 - e) the 5th November, 2021 (Friday), as the date before which the election shall be completed; and
 - C. Fixes the hours from 07:00 AM to 06:30 PM as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
