

**NOTIFICATION**

No. 100/WB-LA/05/2021:— WHEREAS, the seat of Shri Jayanta Naskar, in the Legislative Assembly of the State of West Bengal, elected from 127-Gosaba(SC) Assembly Constituency has fallen vacant on 19<sup>th</sup> June, 2021 due to his sudden demise; and

2. WHEREAS, a bye-election is to be held for the purpose of filling the said vacancy;
3. NOW, THEREFORE, in pursuance of Sections 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission hereby:—
- A. Calls upon the said 127-Gosaba(SC) Assembly Constituency in the State of West Bengal, to elect, before the 5<sup>th</sup> November, 2021 (Friday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Schedule Caste of the State, for the purpose of filling the said vacancy in the Legislative Assembly; and
- B. Appoints, with respect to the said election: —
- a) the 8<sup>th</sup> October, 2021 (Friday), as the last date for making nominations;
- b) the 11<sup>th</sup> October, 2021 (Monday), as the date for the scrutiny of nominations;
- c) the 16<sup>th</sup> October, 2021 (Saturday), as the last date for withdrawal of candidatures;
- d) the 30<sup>th</sup> October, 2021 (Saturday), as the date on which a poll shall, if necessary, be taken;
- e) the 5<sup>th</sup> November, 2021 (Friday), as the date before which the election shall be completed; and
- C. Fixes the hours from 07:00 AM to 06:30 PM as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.
